Street Trading Consent

Thank you for your recent enquiry regarding Street Trading.

Please find attached an application for a Street Trading Consent, which you will need to complete and return and identify a suitable site on which to trade as we are unable to assist you with location. To assist you with your application, also enclosed; Street Trading and Collections Policy, map of Street Trading zones and an application for the Registration of a Food Business Establishment (should your application be food related).

Please ensure you tick the check list on the application form to ensure that you have enclosed the relevant paperwork in support of your application.

If not yet available, an original copy of the certificate of insurance that covers the street trading activity for third party and public liability risks to a minimum of £2,000,000 must be produced should the Consent be granted.

The application should be accompanied by a **non refundable** deposit of 50% of the requisite annual fee as approved by Stratford on Avon District Council. If the application should be approved, the remaining 50% of the fee will be due.

If the fee is not enclosed, the application will be deemed incomplete and will be returned in its entirety.

The fees for the period July 2011 - June 2013 can be found on the back on this letter.
