LONG COMPTON NEIGHBOURHOOD PLAN- SEA SCREENING

Thank you for your consultation and the invitation to comment on the SEA Screening Letter for the Long Compton Neighbourhood Plan. We welcomed the preparation of the Neighbourhood Plan and commended the approaches taken to its' compilation in our previous letter to you of the 11th of December 2013 and those comments are pertinent here also.

We consider that your conclusions that the environmental impacts of the Neighbourhood Plan will not be significant, but will effectively be localised, are correct. Thank you for your consultation on the above dated 29 November 2013, seeking the views and comments of Natural England in respect of the Strategic Environmental Assessment (SEA) Screening, your request has been passed to me as a member of the Land Use Team for response.

Natural England is a non-departmental public body. Our statutory purpose is to ensure that the natural environment is conserved, enhanced, and managed for the benefit of present and future generations, thereby contributing to sustainable development.

The approach and methodology used are acceptable to natural England and in line with the advice that would be offered by Natural England, we are pleased to see reference and clear links to the Local Authority's Core Strategy/Local Plan, along with reference to the National Planning Policy Framework (NPPF). Reference to the Cotswolds Area of Outstanding Natural Beauty (AONB) is also welcomed and commended.

Under the Vision Statement we welcome the references to the protection and enhancement of open spaces (section 4.2).

Also welcomed under Chapter/Section 5: Polices are the references to protection and enhancement of biodiversity and landscape, and the incorporation of landscape consistent with the local character and the AONB (policy H1.4).

Policy H1.6 refers to the protection of fingers of green land and green fields and is also welcomed and could be linked to the sustainable transport modes identified in the Plan, providing green chains and corridors for walking and cycling, where appropriate.

Under Section 5.2 Environment policies E3 – Green Fingers and E8 – Trees and Hedgerows are generally welcomed, but appear to be passive. Reference to enhancing, where possible and appropriate, would strengthen the polices and link in to others sections of the Plan, see above.

Natural England Head Office 1 East Parade Sheffield S1 2ET The approach and methodology is acceptable to Natural England and has referenced appropriate legislation, the issues and topics are those that Natural England would expect to be considered in such a document.

Subject to the above we have no substantive comments to make in respect of this Screening request, however, if, as you develop your plan, you consider that it will have significant impacts on the natural environment then you should consult Natural England again.
