# The 2015 Alcester Neighbourhood Development Plan Household Questionnaire Results



### Neighbourhood Plan

Following the Community engagement events last year the Town Council would now like to know whether residents think the issues identified so far are the right ones, and what people think about the proposed aims and vision for the town. We would also like to find out some further details about specific issues, such as the town centre, new development, the environment, and community facilities in Alcester. This information will be used to prepare policies and proposals which Stratford-on-Avon District Council will use to make planning decisions in Alcester, after the Neighbourhood Plan has been successful in the referendum.

Completed questionnaires were returned by Friday 27<sup>th</sup> March.

### **Your Key Issues**

**30.** From what local people said when consulted on the Neighbourhood Plan we have produced the following list of the key issues which Alcester faces:

- a) The retail offer and services in Alcester town centre should be improved and diversified.
- b) Parking facilities in the town centre are insufficient at peak times.
- c) There is a need to provide more affordable housing for local people in Alcester.
- d) There is a need for more family homes for local people in Alcester.
- e) New housing development must be accompanied by corresponding improvements to infrastructure
- f) New development must not increase the risk of flooding.
- g) Medical services in the town should be improved.
- h) Community facilities in the town should be improved.
- i) Primary school facilities need to be improved.
- j) Open space facilities should be improved.
- k) Provision should be made for employment growth.
- I) There is a need to protect the town's green belt and landscape setting.
- m) Alcester's built heritage is a valuable asset that should be preserved and promoted.

### **Our Proposed Aims of the Neighbourhood Plan**

**31.** From the above issues the following proposed aims were produced for the Neighbourhood Plan. Do you agree that these should be the main aims for the Neighbourhood Plan?

#### **Town Centre**

- SA1: To improve and diversify the range of shopping and other services offered in Alcester Town Centre in order to increase its attractiveness to the local community and to visitors.
- SA2: To improve the provision and effectiveness of ancillary facilities required to support the town centre, including car parking and visitor facilities.

Where strongly agree was given a score of 1 and the others were also given a score to Strongly Disagree being 5, the average score was 1.82

#### New development

- SA3: To accommodate new housing to satisfy strategic local policy and to meet local housing need, including sufficient affordable housing and family housing.
- SA4: To accommodate new employment development to satisfy strategic local policy and provide an extended range of employment opportunities for local people.
- SA5: To ensure that all significant new developments make an appropriate contribution towards the necessary improvements to local infrastructure, such as highways, education, green space, community and other necessary facilities.

- SA7: To preserve and enhance the local historic built environment as a significant cultural and educational resource and an important visitor attraction.
- SA8: To ensure that the landscape setting of the town and its valuable local green space is protected and enhanced.
- SA9: To mitigate the risk of flooding by incorporating appropriate measures within new developments.

### **Our New Development**

- 34. Stratford-on-Avon District Council are producing a new Local Plan which proposes a housing allocation of 350 new dwellings for Alcester on land north of Allimore Lane and 11 hectares of employment land at Arden Industrial Estate. Over the plan period (to 2031) there will no doubt be other development in the town as well. It will be important to ensure that as far as possible this development meets local housing and employment needs, and the town can accommodate the proposed level of growth.

b) Do you agree that Alcester has sufficient employment opportunities for local people?



- **35.** The local environment make a vitally important contribution to the quality of life for people living in Alcester. It is also a major attraction for visitors and tourists, and as a result makes a significant contribution to the local economy. The Neighbourhood Plan can play an important part in ensuring that new development adds to the overall quality of the town and does not detract from it, that the historic environment is preserved, that local green space is protected, and that flood risk is mitigated.
