**Consultation**

Notice is hereby given that Long Itchington Parish Council as the Qualifying Body has prepared a Neighbourhood Development Plan (NDP) entitled the 'Long Itchington, Bascote and Bascote Heath Neighbourhood Plan 2011-2031' for their neighbourhood area with the help of the local community and has formally submitted its plan to the Local Planning Authority.

The Plan sets out a vision for the future of the neighbourhood area and planning policies which will be used to determine planning applications locally. In accordance with Regulation 16 of Part 5 of The Neighbourhood Planning (General) Regulations 2012 (as amended), the Local Planning Authority must now publicise the draft plan for a minimum 6 week period inviting representations on the plan.

The consultation starts on Thursday 22 July 2021. Representations on the draft Plan may be made to the District Council by no later than **5pm on Friday 10 September 2021**.
