Title of document:

Stratford-on-Avon District Site Allocations Plan Revised Preferred Options (June 2022)

The subject matter and area covered:

Stratford-on-Avon District Council has published a Revised Preferred Options version of its Site Allocations Plan for Regulation 18 consultation following a consultation on an initial Preferred Options Plan in October-December 2020.

The Site Allocations Plan covers the whole of the District. It is a Development Plan Document that will accompany the adopted Core Strategy. As well as a number of specific site proposals, the Plan identifies reserve housing sites, sites for self-build and custom build housing, and built-up area boundaries for a range of settlements.

Period for submitting representations:

The consultation on the Revised Preferred Options Site Allocations Plan runs from **Thursday 16 June to 5pm on Friday 29 July 2022**.

During the period for making representations, the Plan will be available for viewing:

Representations may be made electronically or in writing and should be submitted on the prescribed Comment Form so that it is clear what case you are making and, where applicable, how you wish the Plan to be amended.
