

**STRATFORD-ON-AVON DISTRICT COUNCIL
(OFF-STREET PARKING PLACES) ORDER 2023
NOTICE OF PROPOSALS**

STRATFORD ON AVON DISTRICT COUNCIL gives notice that it proposes to make the above Order in exercise of its powers under Section 35 of the Road Traffic Regulation Act 1984 and Regulation 7 of the Local Authorities Traffic Orders (Procedure) (England and Wales) Regulations 1996 (SI 1996/2489) and all other enabling powers.

The effect of the Order is to:

1. Revoke the Stratford-on-Avon District Council (Off-Street Parking Places) Order 2013 (as amended) and reinstate those provisions save for the amendments proposed and re-enact those provisions without any change of substance other than as set out in this notice.
2. Increase charges at the following car parks:
 - Arden Street Car Park, Stratford-upon-Avon
 - Bridgeway Multi-Storey Car Park, Stratford-upon-Avon
 - Bridgeway Surface Car Park, Stratford-upon-Avon
 - Church Street Car Park, Stratford-upon-Avon
 - Recreation Ground Car Park (including the Overspill Car Park), Stratford-upon-Avon
 - Riverside Car Park, Stratford-upon-Avon
 - Riverside Coach & Lorry Park, Stratford-upon-Avon
 - Riverside Motorhome Parking, Stratford-upon-Avon
 - Swans Nest Lane Car Park, Stratford-upon-Avon
 - Windsor Street Multi-Storey Car Park, Stratford-upon-Avon

 - Telegraph Street Car Park, Shipston-on-Stour
3. Add charges and restrictions at an additional car park:
 - Fisherman's Car Park, Stratford-upon-Avon
4. Add restrictions at additional car parks:
 - The Greig Leisure Centre Car Park, Alcester
 - Shipston Leisure Centre Car Park, Shipston-on-Stour
 - Studley Leisure Centre Car Park, Studley
5. Change the name of the main Leisure Centre Car Park and the Leisure Centre Coach & Lorry Park in Stratford-upon-Avon to "Riverside Car Park" and "Riverside Coach & Lorry Park" respectively.
6. Restrict motorhome parking in the renamed "Riverside Motorhome Parking" area in Stratford-upon-Avon to 72 hours with no return within 72 hours.

Full details of the proposals are contained in the draft Order, which may be seen, together with a statement of the Council's reasons for proposing to make the Order and copies of the existing Order at the Council's principle office at Elizabeth House, Church Street, Stratford-upon-Avon, Warwickshire, CV37 6HX between the hours of 09:00 and 17:00 Monday to Friday (excluding bank holidays and public holidays).
