**STRATFORD-ON-AVON DISTRICT COUNCIL
(OFF-STREET PARKING PLACES) (VARIATION) (NO.1) ORDER 2023**

The Stratford-on-Avon District Council (“the Council”) in exercise of its powers under Sections 32, 35 and 35A and under Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (as amended), hereinafter referred to as “the 1984 Act”, and under the Traffic Management Act 2004 (as amended), hereinafter referred to as “the 2004 Act”, and all Regulations and Orders made in exercise of the powers conferred by the 2004 Act and of all other enabling powers, with the consent of the Warwickshire County Council in accordance with Section 39(3) of the 1984 Act and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby makes the following Order.

**PART I
GENERAL**

1. This Order shall come into force on 1 October 2023 and may be cited as “the Stratford-on-Avon District Council (Off-Street Parking Places) (Variation) (No.1) Order 2023”.
2. In this Variation Order, except where the context otherwise requires, the following expressions have the meanings respectively assigned to them:

“the Principal Order” means the Stratford-on-Avon District Council (Off-Street Parking Places) Order 2023,
3. Except where the context otherwise requires, any reference in this Variation Order to an Article or Schedule shall be construed as a reference to that Article or Schedule in the Principal Order.
4. Any reference in this Variation Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
5. The Interpretation Act 1978 shall apply for the interpretation of this Variation Order.

**PART II
AMENDMENT OF THE PRINCIPAL ORDER**

6. The following expression shall be added to Part 1, Article 4 of the Principal Order:

“Concessionary Permit” means an annual permit issued to a Resident of state pension age by the Council in accordance with Part III, Article 1 of this Order.
7. The words “Annual Concessionary Permit: £50.00 (4 hours maximum stay)” shall be added in Schedule 1, Part 1 of the Principal Order at the following car parks only:
 - Bridgeway Multi-Storey Car Park, Stratford-upon-Avon
 - Bridgeway Surface Car Park, Stratford-upon-Avon

**PART III
FULL FORCE AND EFFECT**

8. Save as varied by paragraphs 6 and 7 of this Variation Order, the Principal Order shall continue in full force and effect.
