Introduction

When to use this form

If you are sending an application to a Local Authority under the [Environmental Permitting \(England and Wales\) Regulations 2016](#) and the installation requires an pollution control permit (known as “Part B” installations).

Chapter 4 is about making an application, Chapter 7 is about how permits are decided, and Chapter 12 gives the meaning of Best Available Techniques (BAT). Other chapters introduce the Regulations and give information about various issues.

Noise, odour, particulate matter, carbon monoxide, NOX (Nitrogen oxides) and VOC (Volatile Organic Compounds)
