

Stratford-on-Avon District Council

Annual Community Infrastructure Levy (CIL) Rate Summary for 2024

Stratford-on-Avon District Council's Charging Schedule took effect from 1 February 2018. There is a need to index link CIL contributions annually in order to keep the levy responsive to market conditions. Regulation 40 of the CIL Regulations 2010 (as amended) requires that the index to be used up until 2019 was the BCIS AI-in Tender Price Index and from 2020 CIL payments must be index linked to the Royal Institute of Chartered Surveyors CIL Index published in November of the preceding calendar year: <https://www.rics.org/uk/products/data-products/rics-community-infrastructure-levy-index>.

The index figure for quarter 1 of 2018 was **316**, and the index figure for 2023 is **381**.

The formula set out in the Regulations has been followed and the percentage change of CIL charges from 1st January to 31st December 2023 equates to a **20.57%** increase from the 2018 base rate.

All CIL liable planning applications that are determined between 1 January and 31 December 2023 will include indexation in the calculation of the chargeable amount as set out in the below table.
